MEMORANDUM OF ASSOCIATION.

OF

The Coimbatore Diocese Society.

1. The name of the Society is "The Coimbatore Diocese Society".
2. The registered office of the Society will be located at Coimbatore.
3. The objects for which the Society is established are the promotion of literature and science, the diffusion of useful knowledge, and charitable purposes.
4. The Means employed for the attainment of these objects are:
 - (1) The provision and the maintenance of High schools, Secondary schools, Industrial schools, Elementary schools, Orphanages, Hostels, and Boarding Establishments belonging to the diocese of Coimbatore.
 - (2) The supply and maintenance of professors and teachers therefor and of books and other necessities incidental to imparting education, and carrying out such other educational measures as may from time to time seem good and necessary in the estimation of the Governing body and in accordance with the Madras Educational Code.
5. The names, addresses and occupations of the Governing Body are as follow:-

The Coimbatore Diocese Society.

Rules and Regulations.

Society.

1. The Society shall be called "The Coimbatore Diocese Society."

Governing Body.

2. The Governing Body of the Society shall be the subscribers to the Memorandum of Association and such other persons as may be appointed as herein after provided.

3. In the event of a vacancy occurring among the members of the Governing Body either upon transfer, resignation, or death, such vacancy will be filled up by the appointment of any other member of the clergy or any other religious body of the Coimbatore Diocese, to be made by the chairman of the Governing Body, after having heard the opinion of the remaining or surviving members of such Governing Body, within 3 months from the date of such vacancy.

4. The Members of the Governing Body shall be chosen from among the clergy and religious body of the Diocese of Coimbatore.

5. The Bishop of Coimbatore or his Canonical Representative shall be the Chairman of the Society, and in his absence the Vicar General of the same diocese, who shall be the Correspondent of the Society. The Secretary to the Bishop shall be the Secretary to the Society and the procurator of the Diocese shall be the Treasurer of the society.

6. Once in every year, on or before the 14th day of January a list shall be filed with the Registrar of Joint-Stock companies of the names, addresses and occupations of the Governing Body then entrusted with the management of the affairs of the Society.

Powers of the Governing Body.

7. The Governing Body of the Society shall have power to carry on the business and shall be entrusted with the management of the affair of the Society and shall do such other acts as in their opinion may be conducive to the attainment of the objects of the Society, the right of veto being reserved to the Chairman.

The following existing institutions, and the funds connected therewith, and such other institutions, as may from time to time be established in furtherance of the objects of the Society, shall be under its control:—

8. The Governing Body shall be answerable for the proper maintenance of the institutions above-named and the fulfilment of all conditions of recognition in accordance with the provisions of the Madras Educational Rules and Grant-in-aid Code.

9. A financial statement of the above mentioned schools shall be annually furnished by the Governing Body of the Society to the Director of Public Instruction in accordance with the regulations of the Grant-in-aid Code.

10. In addition to the powers conferred by these presents, the Governing Body shall have power to appoint a Managing Committee consisting of not less than three of its members and to make, vary and repeal by-laws for the regulation of the business of the Society.

11. The Society may invest its funds in Government of India promissory Notes or Securities in the name of the Society, and collect the interests thereon.

12. All the property entrusted to the management of the Society movable and immovable, being vested in the Bishop of Coimbatore pro tempore or his Canonical Representative, all documents relating to the properties of the Society shall be executed for and on behalf of the Society by the Bishop of Coimbatore, or by the Vicar General of the Diocese of Coimbatore and Correspondent of the Coimbatore Diocese Society.

General Meetings, etc.

13. At least one general meeting of the Governing Body shall be held during the year.

14. Four members of the Society shall form a Quorum at such meetings.

15. The chairman at such meetings may then exercise the privilege of a casting Vote
